Exposure to a wide variety of ministry functions was reported in fulltime ministry and teaching for 15 years plus 6 years in part time ministry. The sum of years in ministry therefore equals 18 years in full time ministry. He reports among other qualifications, acquiring a Master's degree in Christian Counselling; a "Doctor of Ministry", as well as a PhD in Ministry from "**Team Impact Christian University**".

Unfortunately, **Team Impact Christian University** is not a SAQA registered institution.

5. EXAMPLES OF MINISTRY OUTPUTS

5.1 Sermon

- **Submitted.** He gave an elaborate discussion about hermeneutics instead of a sermon in which hermeneutics and exegesis should have been applied.

- **Outcome:** Unfortunately, there is no exposition of any texts and therefore no utilization of sound exegesis and hermeneutics. The refresher course in preaching with the focus on exegesis and hermeneutics is strongly required.

.5.2 Talk on ethical or life skills topic or counselling notes

Notes on “The Ministry of Counselling” are submitted.

Outcome: Accepted

5.4 Summary (one page) of ministry plan (visionary, strategic and operational components)

- **Submitted**
- **Outcome:** The Vision and Mission of the plan are not clear. The strategic and operational components therefore are not related to a vision or a measurable mission. The ACRP course on Strategic Planning for Pastors and Ministers to be attended or done in correspondence mode

5.5 Components of a financial management system

- **Submitted**
- **Outcome:** Only a general discussion of the theory of financial management is presented with no mention of specific components. The ACRP refresher course on financial management to be attended or done in correspondence mode.

5.6 Explanation of the difference between an income statement, balance sheet and cash flow statement that will explain what the respective statements are used for

- **Submitted**
- **Outcome:** Answers are correct

5.7 Three questions on interpreting a cash flow statement

- **Submitted**
- **Outcome:** The answers are only partially correct. The candidate did not see that the income for August was only for the first 12 days. The ACRP refresher course on financial management to be attended or done in correspondence mode.

6. SUMMARY OF REPORT

6.1 Summary of Evaluation

Regarding the designation of Religious Specialist, the candidate's Master's and Doctor's degrees can only be evaluated when we have dissertations to assess. The Academic Transcripts and the tables of contents provided by the candidate must be evaluated against the background of the NQF standards of SAQA, and therefore he is urged to present the transcripts (complete dissertations) to SAQA at his own cost. As soon as he gets the results from SAQA he can apply for an upgrade of his designation from ACRP.

In the meantime, the results of his RPL application shows that he qualifies for the designation of Religious Professional. He has been in active ministry for at least 18 years and he has done much academical work and he shows comprehensive insight and knowledge. We want to commend him for presenting us with a comprehensive application. Having said this we discovered that he could do with some help on a few issues and therefore we require of him to enrol for the following refresher courses presented by ACRP;

1. The refresher course in preaching with the focus on exegesis and hermeneutics.
2. The ACRP refresher course on Strategic Planning for Pastors and Ministers.
3. The ACRP refresher course on financial management.


6.2 Recommendations to the Registration Committee

a. Awarding of designation



Every NQF level from 1 -10 is used and regulated by SAQA. In other words only SAQA accredited educational institutes are authorised to use the NQF system. ACRP has no authority to give NQF status to any qualification. **ACRP can only recognize the NQF status already given** by the institution where the qualification

was achieved. In other words your designation as Religious Specialist stands independent of any NQF Level. (Note: There is no designation like Advanced Religious Specialist within the Council for Ministry Training Practitioners – CMTP with which you registered). Your designation is also not an awarding of NQF Level 10 or any other level.

Another misinterpretation that we noticed in your letter of 9 August is that you “hold a non- SAQA registered qualification... but with a ministry relevant non ministry PhD”. The fact is that your PhD is a ministry PhD (in Religious Studies). A ministry relevant qualification would be something like a SAQA accredited University degree in education, psychology, social work, occupational therapy or other non-ministry qualifications which can be demonstrated as being relevant to ministry.

Your designation as Religious Specialist is awarded on the grounds of **6.2.b**. “No SAQA recognised ministry qualification; but applicant is the holder of a non-SAQA recognised ministry qualification accepted by ACRP as M or D equivalent.” In other words we had to see your dissertations to decide whether we could accept your work as M and D equivalent. We are in no position to award you a Qualification, only a Designation. We accepted your qualifications as M and D equivalent. (This is no awarding of an NQF Level 9 or 10 qualification)

A few last remarks:

1. In your letter of 5 August you write: “Point 5.6 cash flow statement, I was found non competent because **I was partly correct.**” You were never found non competent by anyone! The request to enrol for the refresher course in financial management, together with the other two refresher courses is only to enhance excellence.
2. In the same letter you say “My vision and mission was very clear for example:...” and then you write a whole lot of things that were never mentioned in your application forms. We could only work with what we had in front of us.
3. Your CPD requirements changes now to read as follows: Random CPD, with a recommendation for structured CPD or enrolment for an accredited qualification. At least 20 CPD points to be earned annually
